Spain's courts, following the principle of Universal Justice, have just issued **international arrest warrants** today on February 6th, 2008 against **40 leaders of the political-military of the Rwandese army / Rwandese Patriotic Front (RPA/RPF)** for its responsibilities in crimes of genocide, crimes against humanity, war crimes and terrorism, among others, committed in Rwanda and in the Democratic Republic of Congo (formerly Zaire) between 1990 and 2002.
